WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase request No. **2022-C-283** re: **PROCUREMENT OF MEALS, SNACKS, ROOM ACCOMODATION AND USE OF FACILITIES FOR A TWO-DAY ASSESSMENT, STRATEGIC PLANNING AND ORGANIZATIONAL STRUCTURE REVIEW OF THE GOVERNOR'S OFFICE** with an ABC of **₱ 200,000.00**;




