

BAC Resolution Recommending the Use of Alternative Mode of Procurement through Shopping in case of Unforeseen Contingency, Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GO-SPECIAL PROJECT SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0490 re: Provision of transportation for VIP's and guests (local/foreign) by the GO-Special Project Section, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol with an ABC of P 60,000.00;
