WHEREAS, the PROVINCIAL ACCOUNTING OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-240 re: PROCUREMENT OF ACCOMODATION, MEALS AND SNACKS FOR ALL PARTICIPANTS/ ATTENDEES TO THE MID-YEAR ASSESSMENT AND STRATEGIC PLANNING ACTIVITY OF THE PROVINCIAL ACCOUNTING OFFICE with an ABC of ₱ 260, 000.00;
