WHEREAS, the <u>PROVINCIAL ACCOUNTING OFFICE</u> of the <u>PROVINCIAL GOVERNMENT</u> OF BOHOL made procurement under Purchase Request No. 2022-C-240 re: <u>PROCUREMENT OF ACCOMODATION, MEALS AND SNACKS FOR ALL PARTICIPANTS/ATTENDEES TO THE MID-YEAR ASSESSMENT AND STRATEGIC PLANNING ACTIVITY OF THE PROVINCIAL ACCOUNTING OFFICE with an ABC of <u>P 260, 000.00</u>;</u>
