- 6. Maintenance schedule as stipulated above shall be strictly followed however, shall not limit the CONTRACTOR from doing immediate corrective actions regardless of its schedule.
- 7. The CONTRACTOR shall be responsible in supplying the required Test equipment.
- 8. The CONTRACTOR shall adhere with the house rules set by the Provincial Government of Bohol to ensure safety of life and property.
- 9. The CONTRACTOR shall certify in writing that its Engineers and or technician are fully knowledgeable on this activity and has a full knowledge in the equipment used.
- 10. In case of doubts regarding on the equipment to be accessed by the CONTRACTOR, the latter shall be required to coordinate immediately to the Provincial General Services Office (PGSO) personnel on-duty.
- 11. Horse playing, loitering or doing any unnecessary activity not related to this requirement is strictly prohibited
- 12. The CONTRACTOR shall cover any expenses for any restoration of any possible breakdown of equipment brought about by the negligence on the part of the CONTRACTOR.
- 13. The CONTRACTOR shall provide an appropriate operator's training/orientation on proper operation base on maintenance and emergency response procedure.
