WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2022-0505 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL YOUTH DEVELOPMENT OFFICE in undertaking Procurement Request under PR No. 2022-C-126 re: PROCUREMENT MEALS DURING THE SERIES OF SPORTS ACTIVITIES & MEETINGS UNDER DUWA COMPONENT OF LAUM BOHOL with an ABC of P 352, 500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.</u> as reflected in the Abstract of Bid Proposals;
