WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0203 -re; Procurement of Various Office Supplies & Housekeeping Supplies, by the Provincial Economic Enterprise Management Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 71,990.00;
