



**BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding,  
Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0407 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE** in undertaking Procurement Request under PR No. 2022-0221, re: Procurement of Desktop Computer, DSLR Camera & Smart TV, by the Bohol Provincial Environment Management Office, New Capitol Building, Tagbilaran City, with an ABC of **₱ 240,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
