WHEREAS, the <u>BOHOL EMPLOYMENT AND PLACEMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL made</u> procurement under Purchase Request No. <u>2022-C-232</u> re: <u>PROVISION OF HOTEL ACCOMMODATION WITH MEALS AND SNACKS FOR THE AGENCY REPRESENTATIVES DURING THE LOCAL AND OVERSEAS JOB FAIR with an ABC of <u>P 294, 000.00</u>;</u>
