BAC Resolution Recommending the Use of Alternative Mode of through Direct Contracting, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0473, re: Procurement of Medical Oxygen, Breathing Apparatus, Cylinder Hydrotest & Cylinder Change Valve for Emergency Response of TaRSIER 117 including the COVID -19 Response with an ABC of P 198,000.00;
