WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. **2022-0473**, re: Procurement of Medical Oxygen, Breathing Apparatus, Cylinder Hydrotest & Cylinder Change Valve for Emergency Response of TaRSIER 117, including the COVID -19 Response with an ABC of P 198,000.00;

WHEREAS, the above Procurement Request was presented to the **BIDS AND AWARDS COMMITTEE** for deliberation and proper action;


