WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0299 re; Procurement of Various Office Supplies, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 279,978.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




