WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2022-0830 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **GOVERNOR'S OFFICE** in undertaking Procurement Request under PR No. 2022-0393 re; Procurement of Fuel (Diesel) for use at Logistical Support and Resource Counterpart for Special Operations including Emergency or Crisis Response Activities of Law and Order and Surveillance Activities Including ELCACs Monitoring for use at the Governor's Office, Bohol Provincial Capitol Building, Tagbilaran City. with an ABC of **₱ 499,999.63;**
