BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0454, re; Procurement of various Electrical and Plumbing Materials, by the Provincial General Services Office New Capitol Building, Cogon District, Tagbilaran City, with an ABC of P 265,872.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare **PRIM E CONSTRUCTION SUPPLIES TRADING** as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022-0323;
- b.) To recommend award to **PRIM E CONSTRUCTION SUPPLIES TRADING** for the delivery of goods/services under Negotiated Canvass No. 2022-0323 in the amount of P 264,311.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


