

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 -070** re: **PROCUREMENT OF MEDICAL SUPPLIES FOR THE USE DURING THE NATIONAL AIDS & STI PREVENTION & CONTROL PROGRAM** with an ABC of **P 166,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BYRO PHARMA CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to **BYRO PHARMA CORPORATION** in the amount of **ONE HUNDRED SIXTY FIVE THOUSAND FOUR HUNDRED TEN PESOS ONLY (P 165,410.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2022 - 029**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


