BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 22-229 Series of 2022

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 080 re: PROCUREMENT OF BP APPARATUS, AMLODIPINE, LOSARTAN & METFORMIN with an ABC of P 224,999.45;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BYRO PHARMA CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BYRO PHARMA CORPORATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BYRO PHARMA CORPORATION has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BYRO PHARMA CORPORATION as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 222,557.45 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. PHO 2022 030;
- b.) To recommend award to BYRO PHARMA CORPORATION in the amount of TWO HUNDRED TWENTY TWO THOUSAND FIVE HUNDRED FIFTY SEVEN PESOS AND 45/100 (P 222,557.45) for the delivery of goods under Negotiated Canvass No. PHO 2022 030;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
