WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0328 re; Procurement of Various Office Supplies, by the Provincial Human Resource Management & Development Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 547,460.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




