BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL YOUTH DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0049, re; Procurement of Van Rental for the Conduct of Psychological First Aide for the Survivors of Typhoon Odette in the Most Affected LGUs, by the Provincial Youth Development Office, New Capitol Compound, Tagbilaran City. with an ABC of P 210,000.00;
