WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0801 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL INVESTMENT PROMOTION CENTER** in undertaking Procurement Request under PR No. **2022-C-212** re: **PROVISION OF ROOM ACCOMMODATION AND CATERING SERVICES FOR THE MID-YEAR ASSESSMENT AND TEAM-BUILDING ACTIVITY OF BEDIPO** with an ABC of **₱ 49,000.00**;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that **BOHOL BEE FARM RESORT AND FRANCHISING CORP.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
