BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0811 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Producement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the PROMOTION CENTER in undertaking Procurement Request under PR No. 2022-C-211 re: PROVISION OF CATERING SERVICES FOR THE INVESTMENT PROMOTION AND MARKETING BUSINESS FORUMS, LOCAL ECONOMIC DEVELOPMENT, INCENTIVES AVAILMENT PROMOTION, ECONOMIC AND INVESTMENT RESEARCH AND OTHER INVESTMENT SERVICES ACTIVITIES with an ABC of P 39, 800.00;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC, has been found to be ELIGIBLE and its bid, RESPONSIVE;
