

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0252-A series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2022-0180 re; Procurement of Bouyancy Control Device, Regulator (Complete Set) & Underwater Camera, by the Bohol Provincial Environment Management Office, New Capitol Building, Tagbilaran City. with an ABC of ₱ 250,361.28;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CEBU ERNBRI IMPORT, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
