

**PROCUREMENT OF VENUE WITH ACCOMMODATION, MEALS
AND SNACKS FOR THE BICTO MID-YEAR ASSESSMENT**

CONTRACT AGREEMENT

No: **2022-127**

THIS AGREEMENT, made this 4th day of August, 2022 between **BOHOL INFORMATION, COMMUNICATION AND TECHNOLOGY OFFICE** of Provincial Government of Bohol (hereinafter called the "Entity") and **THE BELLEVUE RESORT/BELLE SOUTH PACIFIC PROPERTIES, INC.** of Doljo, Panglao, Bohol (hereinafter called the "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **VENUE WITH ACCOMMODATION, MEALS AND SNACKS FOR THE BICTO MID-YEAR ASSESSMENT** and has been accepted a Bid by the Supplier for the supply of those goods and services in the sum of **P 120,000.00** in **One Hundred Twenty Thousand Pesos Only**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of the Contract; and;

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Hundred Twenty Thousand Pesos Only** or such other sums as may be ascertained, **THE BELLEVUE RESORT/BELLE SOUTH PACIFIC PROPERTIES, INC.** agrees to the **VENUE WITH ACCOMMODATION, MEALS AND SNACKS FOR THE BICTO MID-YEAR ASSESSMENT** in accordance with his/her/its Bid.
4. The **BOHOL INFORMATION, COMMUNICATION AND TECHNOLOGY OFFICE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. In consideration of the payments to be made by the Entity to the Supplier, as earlier mentioned, the Supplier hereby covenants with the Entity to implement and complete the Project in conformity with the provisions of the Contract, the documents incorporated herein and the laws and regulations made integral parts hereof.
6. The Supplier agrees to comply with the technical requirements for each type of events. See attached **Menu** for the details.
7. In the event that the actual number of attendees is more than the agreed number stipulated in **Purchase Request** of this contract, the Entity shall pay the corresponding difference.
8. The Entity shall be obliged to pay the Supplier based only on the actual attendees, provided that the latter is informed within 5 working days before the scheduled date of the activity of the changes on the catering and accommodation services requirement that may arise.
9. The Supplier shall be required to serve homegrown Boholano food products.
10. The Supplier agrees to observe the "Zero Single-Use Plastics Policy" as per Memorandum by the Provincial Government in support to the Green Public Procurement Program in adherence to GPPB Resolution No. 25-2017.
11. The Entity shall furnish to the Supplier the original copy of the Guest Folio, Attendance Sheet and Inspection and Acceptance Report immediately after each activity conducted.
12. The total cost of catering and accommodation services shall include the use of the premises of the Supplier at no extra cost. However, should the place designated by the Supplier be different, the arrangement and cost of such place which should be acceptable to the Entity shall be the responsibility of the Supplier.


