WHEREAS, the **DEPARTMENT OF EDUCATION/ GO-EDCENTER** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. 2022-C-234 re: PROVISION OF ACCOMMODATION, MEALS AND SNACKS FOR THE PSYCHOLOGICAL FIRST AID (PFA) ACTIVITY (GAD) - BASED FOR PUBLIC SCHOOLS DISTRICT SUPERVISORS (PSDS) with an ABC of P 260, 000.00;
