BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE GOVERNOR, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0577 re; Provision for Rental of LED Wall and Audio Visual Equipment and other Logistical Requirements, with an ABC of P 310,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LUPAD – NATANIEL LUPERTE PHOTO AND VIDEO SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






