BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE GOVERNOR, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0577 pe; Provision for Rental of LED Wall and Audio Visual Equipment and other Logistical Requirements, with an ABC of P 310,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>LUPAD – NATANIEL LUPERTE PHOTO</u> <u>AND VIDEO SERVICES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>LUPAD – NATANIEL LUPERTE PHOTO AND VIDEO SERVICES</u>, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>LUPAD – NATANIEL LUPERTE PHOTO AND VIDEO SERVICES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
