BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0483, re: Provision of IEC material for Nutrition information, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 95,840.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;






