WHEREAS, the PROVINCIAL BUDGET MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-112 re: PROVISION OF CATERING AND ACCOMMODATION SERVICES FOR THE PBMO MID-YEAR ASSESSMENT with an ABC of ₱ 120,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that BELLE SOUTH PACIFIC PROPERTIES, INC./ THE BELLEVUE RESORT offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
