WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2022-0476 re; Procurement of Electrical Supplies, by the Provincial General Services Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 693,045.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:
