**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 246 re: PROCUREMENT OF VARIOUS JANITORIAL/HOUSEKEEPING SUPPLIES with an ABC of P 395,457.99;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that HTG CLEANING SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of HTG CLEANING SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid HTG CLEANING SUPPLIES TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare HTG CLEANING SUPPLIES TRADING as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 394,443.48 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2022 - 154;
- b.) To recommend award to HTG CLEANING SUPPLIES TRADING in the amount of THREE HUNDRED NINETY FOUR THOUSAND FOUR HUNDRED FORTY THREE PESOS AND 48/100 (P 394,443.48) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 154;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


