BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL</u>, <u>CARMEN, BOHOL</u>. of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2022 - 230</u> re: <u>PROCUREMENT OF VEHICLE TIRES</u> with an ABC of <u>P 59,200.00</u>.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY TYRE SALES AND SERVICE CENTER</u>, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,
