**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA (PITOGO), BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 251 re: PROCUREMENT OF HOUSEKEEPING SUPPLIES with an ABC of P 159,245.00;






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare HTG CLEANING SUPPLIES TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 158,493.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2022 - 151;
- b.) To recommend award to HTG CLEANING SUPPLIES TRADING in the amount of ONE HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED NINETY THREE PESOS ONLY (P 158,493.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 151;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


