WHEREAS, the FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 237 re: PROCUREMENT OF OFFICE SUPPLIES with an ABC of P 80,210.00.




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


