 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 241 re: PROCUREMENT OF HOUSEKEEPING SUPPLIES with an ABC of P 419,920.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that HTG CLEANING SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings






