WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY. of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 068 re: PROCUREMENT OF SUBSCRIPTION OF PHIC & DOH ACCREDITED SYSTEM FOR THE ELECTRONIC CLAIMS WITH
