WHEREAS, upon the conduct of post qualification by the Technical Working Group, BEROVAN MARKETING, INC, met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **BEROVAN MARKETING, INC** the bidder declared as the SINGLE CALCULATED BID, successfully passed the Post Qualification process, thus the Committee now considered its bid as the SINGLE CALCULATED and RESPONSIVE BID for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a.) To declare **BEROVAN MARKETING, INC** as the **SINGLE CALCULATED** and **RESPONSIVE BID** for items no. 3, 4, 5, 6, 7, 9 & 10 in the amount of **P 1,308,185.00** for the Procurement of **VARIOUS MEDICAL** EQUIPMENT FOR GMPH VARIOUS WARD USE under Project Reference No.- PHO - 2022 - 050; while items no. 1, 2, 8 & 11 having no quotation from the supplier are recommended for Negotiated Mode of Procurement thru 2nd failure of Bidding.
