WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 189 re: PROCUREMENT OF CURTAIN BLINDS FOR DIALYSIS CENTER with an ABC of P 77,604.67.




