WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. 2022-323 series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL** in undertaking Procurement Request under PR No. – PHO – 2022 – 146 re: Procurement of 2 Stations Dialyzer Reprocessing Machine and Acid Mixer with an ABC of P 530,000.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






