WHEREAS, the PROVINCIAL LEGAL OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0503 re; Procurement of Executive Chairs for use at the Provincial Legal Office, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of P 56,100.00;
