WHEREAS, the **PROVINCIAL LEGAL OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0503, re; Procurement of Executive Chairs for use at the Provincial Legal Office, New Capitol Compound, Tagbilaran City, Bohol, with an ABC of P 56,100.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


