BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2022-0511 re: Procurement of TYRES with Inner Tube & Flaps, Assigned under the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City, with an ABC of P 123,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **NORTHWAY TYRE CENTER** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **NORTHWAY TYRE CENTER** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;






