WHEREAS, the **PROVINCIAL PLANNING DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-200** re: **PROCUREMENT OF ROOM ACCOMODATION, MEALS, SNACKS AND VENUE FOR THE 2022 PPDO MID-YEAR ASSESSMENT AND OPERATIONAL PLANNING WORKSHOP** with an ABC of **₱ 175, 500.00;**


