WHEREAS, the PROVINCIAL TREASURY OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-180 re: PROCUREMENT OF ROOM ACCOMMODATION AND CATERING SERVICES FOR THE MID-YEAR ASSESSMENT with an ABC of ₱ 240, 000.00;


