BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, during the opening of bids on JULY 20, 2022, the following suppliers **BYRO PHARMA CORPORATION & RGZI MEDICAL AND LABORATORY SUPPLY** drop its bid proposal for the said procurement;

WHEREAS, in the detailed evaluation of bids **RGZI MEDICAL AND LABORATORY SUPPLY** was declared as the Lowest Calculated Bid as Read in the amount of P 480,202.34;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **RGZI MEDICAL AND LABORATORY SUPPLY**, met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **RGZI MEDICAL AND LABORATORY SUPPLY** the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a.) To declare **RGZI MEDICAL AND LABORATORY SUPPLY** as the **LOWEST CALCULATED and RESPONSIVE BID** in the amount of P 480,202.34 for the Procurement of **MEDICINE FOR THE NATIONAL AIDS AND STI PREVENTION AND CONTROL PROGRAM** under Project Reference No.- **PHO - 2022 – 069**;
- b.) To recommend award to **RGZI MEDICAL AND LABORATORY SUPPLY** in the contract amount of **FOUR HUNDRED EIGHTY THOUSAND TWO HUNDRED TWO PESOS AND 34/100 (P 480,202.34)**;
- c.) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
