WHEREAS, the **BOHOL TOURISM OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0261, re; Procurement of Tour Handler Services During the Tourism Promotion & Marketing Activities, by the Bohol Tourism Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 775,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PAMILACAN ISLAND DOLPHIN & WHALE WATCHING TOURS.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
