**WHEREAS**, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-173** re: **PROCUREMENT OF MEALS AND ROOM ACCOMODATION FOR THE VISITING DIGNITARIES, GUESTS, DELEGATES AND VISITORS FOR OFFICIAL MEETINGS, CONFERENCE AND EXHIBITIONS HOSTED/ HELD IN THE PROVINCE** with an ABC of **₱ 415,000.00**;



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:






