WHEREAS, the OFFICE OF THE SANGGUNIANG PANLALAWIGAN - SP SECRETARIAT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0155 re; Procurement of Two Unit Computer Laptop, One Unit LCD Projector & One Unit Uninterruptible Power Suuply (UPS), by the Office of the Sangguniang Panlalawigan - SP Secretariat, New Capitol Compound, Tagbilaran City, with an ABC of P 202,864.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




