WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of go under Purchase Requests No. <u>2022-0419</u> re; <u>Procurement of Secondary Clutch</u>, <u>Tubeless Tires</u>, <u>Seat Upholstery with Labor the Injection Pump for the Mitsubishi Strada</u>, <u>Double Cab pick-up</u>, <u>7C-CL-005</u>, by the Provincial Engineer's Office, <u>New Car Compound</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 150,110.00</u>;
