WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0419 re; Procurement of Secondary Clutch, Tubeless Tires, Seat Upholstery with Labor the Injection Pump for the Mitsubishi Strada, Double Cab pick-up, 7C-CL-005, by the Provincial Engineer's Office, New Car Compound, Tagbilaran City. with an ABC of P 150,110.00;
