RESOLUTION NO. <u>22-0</u>580 Series of 2022

WHEREAS, the PROVINCIAL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-133 re: PROVISION OF MEALS AND SNACKS FOR THE GUESTS AND PARTICIPANTS OF THE TOURISM RELATED FORA AND PTC FULL COUNCIL MEETING with an ABC of P 66,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANGLAO</u> <u>BLUEWATER RESORT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of PANGLAO BLUEWATER RESORT including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, PANGLAO BLUEWATER RESORT has been found to be ELIGIBLE and its bid, RESPONSIVE;
