WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0144 re; Procurement of Electrical Supplies, by the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City. with an ABC of P 121,090.00;
